### 2022 Planning Agency of the Year Award


The Florida Commission for the Transportation Disadvantaged recently recognized the Martin Metropolitan Planning Organization (MPO) as the *2022 Planning Agency of the Year*. This award is for the planning agency that has gone beyond their

scope to assist transportation disadvantaged (TD) citizens in their area. Martin MPO has included transportation disadvantaged planning into its local plans and has worked closely with the Senior Resource Association, Martin County's Community Transportation Coordinator, to overcome local transportation barriers and to advocate on behalf of the transportation disadvantaged population.

#### Development Review Interactive Map

The Martin MPO Policy Board requested that MPO staff work with the local governments to map approved and proposed land developments in Martin County and its municipalities. Following this request, MPO Staff, along with its consultant, Northstar Geomatics,



developed an interactive map showing County and municipal land developments which will be updated twice a year. The MPO Advisory Committees stated that they

were happy with this new tool. The map was presented to the MPO Board and was unanimously approved. This will help the MPO Board when prioritizing projects on the annual List of Project Priorities (LOPP).

## **Vision Zero Plan**

Over the past five years, Martin County has welcomed 10,000 new residents and the number of annual visitors continues to climb. During the same time, there have been over 8,000 crashes on roads in Martin County. Of these crashes, 351 resulted in death or serious injury.



The Martin Metropolitan Planning Organization (MPO) and its partner local governments are taking a bold stand to no longer accept these traffic fatalities and injuries as status quo. Our commitment is Vision Zero, which is a traffic safety initiative to reduce crashes and eliminate traffic-related deaths and serious injuries. Why? Because one traffic-related death is one too many.

On May 9th, 2022, the Martin MPO Policy Board approved the Vision Zero Plan, which outlines focus areas and specific recommendations to move the County towards its goal of zero fatalities and serious injuries. To view the Vision Zero Plan, please visit martinmpo.com, or click on the button below.

The MPO has created a Project Advisory Committee which consists of staff from Martin County and its municipalities to help guide the



project. The goal is to develop a project prioritization process for transportation related resiliency projects so that local governments can plan for the future of the transportation network.
