On June 24, 2022, the CTD approved the grant funding for State Fiscal Year 2022-23. Two grants were awarded to the Martin County CTC, Senior Resource Association (SRA); the Innovative Service (ISD) Grant (CTD approved August 16<sup>th</sup>, 2022) and the Trip & Equipment (T&E) Grant. As you are aware, we have had to limit trips for TD population in the past. However, now with the new ISD Grant funding that will help provide trips for dialysis patients to get to dialysis centers and other quality of life destinations, this frees up funding to be used for other eligible TD clients in the county and with no trip limits.

# Monday, June 6, 2022 at 10:00 A.M. MINUTES

#### 3. APPROVE AGENDA

A motion was made by Bob McPartlan to approve the Agenda as presented. A second was provided by Phyl Weaver. The motion passed unanimously.

#### 4. APPROVE MINUTES

Regular Meeting Minutes – March 7, 2022

A motion was made by Phyl Weaver to approve the Regular Meeting Minutes of March 7, 2022. A second was provided by Bob McPartlan, the motion passed unanimously.

#### 5. COMMENTS FROM THE PUBLIC

Melody Hearn, Family Care Council, Area 15 came forward and thanked the LCB-TD Committee for their continued support to the transportation for the disadvantaged.

#### 6. AGENDA ITEMS

#### A. QUARTERLY PERFORMANCE REPORT

Lucine Martens introduced Mr. Chris Stephenson of the Senior Resource Association (SRA) who summarized the Quarterly Performance report. The CTC, SRA has used 100% of the available Trip and Equipment (T&E) Grant dollars this fiscal year, with the vast majority of the trips being medical. Karen Deigl, Senior Resource Association, encouraged the Committee to speak with the County Commission to support additional funding to the TD program including overmatch.

Bob McPartlan inquired about the scheduling languages that are available to those who call to schedule a trip. Chris Stephenson explained that it is only in English but he would look into other alternatives. Bob McPartlan asked if the funding could come from another source such as United Way? Chris Stephenson and Karen Deigl said that it has been done in Indian River County and could be a potential funding match. Karen Deigl explained that with the minimum 10% match and with additional match funds this will increase funding from the State each year. Bob McPartlan encouraged the public to request the additional match funding from the County Commission. He also suggested reaching out to the not-for profit agencies for additional funding.

A motion was made by Bob McPartlan to approve the Quarterly Performance Report. A second was provided by Dalia Dillon, the motion passed unanimously.

# B. FY22 COMMUNITY TRANSPORTATION COORDINATOR (CTC) EVALUATION UPDATE.

Lucine Martens presented this item and explained the evaluation update process that is done every year. This year's evaluation resulted in no action items and she complimented Senior Resources Association for their outstanding work. Merritt Matheson thanked all those who participated in the evaluation process including those who participated in ride-along trips and made phone calls to TD riders.

Bob McPartlan complimented Senior Resources Association on their outstanding work. Bob McPartlan, a LCB-TD member who also works with SRA in Indian River County, stated that each year it is very hard to find anything that SRA needs to improve upon.

A motion was made by Phyl Weaver to approve the FY22 Community Transportation Coordinator (CTC) Evaluation. A second was provided by Bob McPartlan, the motion passed unanimously.

Karen Deigl stated they would be attending the next Martin County Commission Meeting to request the additional match funding. She encouraged support from the Committee and public at that meeting.

## C. TRANSPORTATION DISADVANTAGE (TD) PROGRAM FY 22/23 ALLOCATION

Lucine Martens presented this item with the following proposed allocations for FY22/23:

- CTD Trip and Equipment Grant \$333,504,
- Transportation Disadvantage Planning Grant, \$23,350.00

The Governor has not yet officially signed the allocations to date.

# D. FY23 COMMUNITY TRANSPORTATION COORDINATOR (CTC) TRIP RATE MODEL.

Lucine Martens introduced Chris Stephenson of Senior Resources Association who came forward and explained the proposed rate and reimbursement for ambulatory and wheelchair trips. He explained that the TDSP will need to be amended by July 1, 2022 if approved by the Local Coordinating Board for the Transportation Disadvantaged Board.

After a brief discussion and concern that the new rates would not be enough to cover the rising gas prices and labor cost, Chris Stephenson and Karen Deigl, assured the Board that they have factored into the rates the rising cost.

A motion was made by Bob McPartlan to approve the FY23 Community Transportation Coordinator (CTC) trip rate model. A second was provided by Dalia Dillon, the motion passed unanimously.

# E. TRANSPORTATION DISADVANTAGED SERVICE PLAN (TDSP) MINOR UPDATE

Lucine Martens introduced the item and stated that in anticipation of approval of item 6 D, it is requested to amend the trip rate to the TDSP.

A motion was made by Phyl Weaver to approve the Transportation Disadvantaged Service Plan (TDSP) minor update. A second was provided by Bob McPartlan, the motion passed unanimously.

The Trip and Equipment Grant funded 10,015 trips for the county's TD population during the 2021-2022 fiscal year.

- 7,662 ambulatory trips
- 2,353 wheelchair trips

There have been 2,067 trips cancelled by passengers.

• This shows us that passengers are forecasting their trips needs appropriately and understanding how to maximize the trip limit to get to needed appointments, etc.

100% of the available trip and equipment grant dollars were spent.








#### Florida Developmental Disabilities Council Mobility Grant

In August, 2020 SRA was approached by staff from the Florida Developmental Disabilities Council (FDDC) and tasked with putting together a pilot program to help individuals with developmental disabilities have access to more mobility options. This pilot program began October 1<sup>st</sup>, 2020 and will continue until at least June 30, 2023. The program serves all 4 counties along the Treasure Coast (Indian River, Martin, St. Lucie and Okeechobee). Anyone who has a developmental disability is eligible to book trips, and all trips are carried out by drivers with training specific for working with people with developmental disabilities. Last FY there were 13,00 trips done in Martin County and 33,000 on the Treasure Coast:



# **Indiantown Saturday Shuttle**

- SRA received another 5310 grant for the second year of the program in 2021

This fiscal year we had 2,335 passengers (a 47% increase)


# **Future Funding**

There was a reduction in funding for Martin County trips last fiscal year. A "trip limit" had been imposed on the passengers to handle the shortage. Unfortunately, the Trip and Equipment Grant formula resulted in another loss in funding for Martin County in the 22/23 Fiscal Year.

However, on May 13<sup>th</sup>, 2022 SRA applied for a \$750,000 Innovative Service Development Grant for Martin County through the Commission for Transportation Disadvantaged. It was approved in June, 2022. SRA can fund all of Martin County's dialysis passengers' trips through the ISD grant and only use the Trip and Equipment Grant for non-dialysis trips. Martin County is providing the additional match dollars. The grants were executed August 18<sup>th</sup>, 2022.

SRA also received a \$1.2 Million grant from the Commission for Transportation Disadvantaged and \$100,000 from FDOT for the Advantage Ride Program. Our partners in St. Lucie County and Indian River County are providing the additional match dollars for these grants.



The Trip and Equipment Grant funded 731 trips for the county's TD population during the first month of the 2022-2023 fiscal year.

- 497 ambulatory trips
- 234 wheelchair trips

There have been 69 trips cancelled by passengers.

100% of the available trip and equipment grant dollars were spent.







## **BACKGROUND**

DOPA (Martin MPO) staff, including Beth Beltran and Lucine Martens, and Ash Bleecher of Martin County Transit (MARTY) attended the Florida Commission for The Transportation Disadvantaged (CTD) Training Workshop & Expo on August 30-31, 2022.

## **ISSUES**

The CTD Training Workshop and Expo provided us with toolkits to enhance our ability to work with the Martin County Community in authentic ways which is essential to our planning and coordination process.

At the CTD Training Workshop and Expo, the Florida Commission for the Transportation Disadvantaged recognized the Martin Metropolitan Planning Organization (MPO) as the **2022 Planning Agency of the Year**. This award is for the planning agency that has gone beyond their scope to assist transportation disadvantaged citizens in their area. Martin MPO has included transportation disadvantaged planning into its local plans and has worked closely with the Senior Resource Association, Martin County's Community Transportation Coordinator, to overcome local transportation barriers and to advocate on behalf of the transportation disadvantaged population.

The Senior Resource Association (SRA) was recognized as the **2022 Urban Community Transportation Coordinator**, performing in an outstanding manner as part of the fully coordinated system for the transportation disadvantaged (TD) community in Martin County. SRA operates Martin Community Coach which is a door-to-door transportation system for TD eligible riders. Eligibility is based on age (65 years or older), disability or income.
