# A. Annual Public Workshop

Lucine Martens, MPO Planner, began the annual public workshop by explaining to new members the TD system and introduced the Senior Resource Association (SRA) who serves as the Community Transportation Coordinator (CTC) for Martin County.

Robert McPartlan asked when the last time our MARTY system routes have been assessed. Lucine Martens informed him of the Transit Efficiency Study which is nearing completion and there will be future open house sessions for the MARTY Transit Development Plan coming soon.

Becky Keith proposed looking at Indiantown for guidance on a Saturday and Sunday service.

Lucine Martens, put the number to request Martin Community Coach (MCC), TD transportation on the record "772-469-2063". Lucine Martens also asked if SRA could provide business cards with a QR code linked to MCC information and application for TD transportation requests.

#### B. LCB-TD MEMBER TRAINING

Lucine Martens, showcased a presentation for the LCB-TD Member Training.

**5. COMMENTS FROM COMMITTEE MEMBERS** - Phyl Weaver asked about the current eligibility requirements and discussed the 65+ population. Chris Stephenson informed Phyl Weaver that the current criteria is set by the LCB-TD; eligibility is based

on whether the person is over 65, or has a disability, or lives under 100% of the poverty level, and that person has no other form of transportation.

Ashman Beecher with MARTY (Martin County Transit) asked when the next Transportation Disadvantaged Service Plan (TDSP) update will be. Lucine Martens stated that it would be in 2025.

## A. QUARTERLY PERFORMANCE REPORT

Lucine Martens, MPO Planner, introduced Chris Stephenson of the Senior Resource Association (SRA) who presented the Quarterly Performance Report for the period covering the end of the fiscal year that ended June 30<sup>th</sup>, 2023 to the first month of the current fiscal year. Chris Stephenson emphasized the 120% increase in trips from the previous fiscal year. Chris also spoke of the phone system they implemented to curb the number of "no-shows".

Robert McPartlan asked Chris Stephenson whether the funding would be available in the future years for the Treasure Coast Developmental Disability Advantage Ride program. Chris informed Robert that it is funded through June 30, 2024, but there is no guarantee after that, however, SRA is actively seeking additional funding for the future.

Robert McPartlan also had a question about the Indiantown Shuttle and whether they had to meet the same requirements as the Commission for the Transportation Disadvantaged. Chris informed him that anyone can get on the Indiantown Shuttle and that it operates as public transit.

Council Member Susan Gibbs-Thomas asked if the "no-shows" get counted into any other figures. Chris Stephenson informed her that they do not.

Chris Stephenson and Robert McPartlan further discussed current fiscal numbers versus previous fiscal year numbers, as well as future projections.

A motion was made by Phyl Weaver to approve the Quarterly Performance Report, seconded by Robert McPartlan. The motion passed unanimously.

## **B. LCB-TD MEMBER INTRODUCTIONS**

With the addition of new members to the LCB-TD, the Metropolitan Planning Organization (MPO) staff thought that it would be in the best interest of the Board to familiarize themselves with the other members. Each present member of the LCB shared a brief introduction about who they are, who they represent, and how they are involved with the TD population.







# **Martin County Indiantown Shuttle**




# **Indiantown Saturday Shuttle Statistics**

# Treasure Coast Developmental Disability Advantage Ride

In August, 2020 SRA was approached by staff from the Florida Developmental Disabilities Council (FDDC) and tasked with putting together a pilot program to help individuals with developmental disabilities have access to more mobility options. This program began October 1<sup>st</sup>, 2020 and will continue until at least June 30, 2024. The program serves all 4 counties along the Treasure Coast (Indian River, Martin, St. Lucie and Okeechobee). Anyone who has a developmental disability is eligible to book trips, and all trips are carried out by drivers with training specific for working with people with developmental disabilities.

### Specialized Transportation Coordination Agreement

This Coordination Agreement is entered into by the Community Transportation Coordinator, Senior Resource Association, Inc., hereinafter referred to as the CTC, and Helping People Succeed, hereinafter referred to as the Agency. The terms and conditions of this agreement are effective July 1, 2020 and will continue through June 30th, 2023.

Whereas, federal transit law, as amended by MAP-21(Moving Ahead for Progress in the 21st Century) in 2012, requires that projects selected for funding under the Federal Transit Administration's Section 5310 grant program be "included in a locally developed, coordinated public transit-human services transportation plan" and that the plan be "developed and approved through a process that included participation by seniors, individuals with disabilities, representatives of public, private, and nonprofit transportation and human services providers and other members of the public"; and,

Whereas sub-recipients of 5310 grants administered by the Florida Department of Transportation (FDOT) must be either a CTC or providing service under the terms of a written agreement with a CTC; and,

Whereas under the terms of this agreement, the CTC acknowledges that the Agency is providing transportation services to meet the needs of seniors and individuals with disabilities where public transit services are unavailable, insufficient or inappropriate and is part of the Florida Coordinated Transportation System (FCTS).

As part of the FCTS, the Agency agrees to:

- Coordinate with staff from the Metropolitan/Transportation Planning Organization, the CTC, the Commission for the Transportation Disadvantaged (Commission), and the FDOT to ensure that the transportation services the Agency provides and the Agency transportation needs and gaps in service are sufficiently and accurately represented in the Transportation Disadvantaged Service Plan.
- Provide vehicles and support in emergency situations (see Attachment A for definition), and for evacuation and natural disaster recovery operations if requested by the CTC.
- Whenever possible, provide support and coordinate transportation with the CTC and other human service agencies in the FCTS.
- Report trip data in a timely manner as requested by the CTC.
- Comply with all Section 5310 requirements as described in the annual Section 5310 Application Manual.
- Have a CTCAgreement current and in force at all times when receiving an award under the Section 5310 Program and keep current and in force every year until the vehicle(s) reaches its useful life requirement.

- Remain in good standing with the CTC by complying with the obligations specified in this Agreement. The CTC retains the right to terminate this agreement for cause as specified in this agreement.
- Annually certify to the CTC and FDOT that:
  - Vehicles obtained through a Section 5310 award are being used for the purpose stated in the Section 5310 grant application;
  - o The Agency is in compliance with Title VI requirements;
  - O Vehicles are insured for the required amount, Insurance is current, and FDOT is listed as the Certificate Holder on the policy when Agency has obtained vehicles through a 5310 award and where FDOT remains the lienholder;
  - Vehicle are properly maintained according to an FDOT approved preventive maintenance plan; and,
  - o Accidents are reported to FDOT and the CTC within 24 hours of occurrence.

Termination-The CTC may terminate this Agreement for the Agency's insufficient performance with written notice to the Agency detailing the insufficient performance.
